Human Milk Feeding

- Thank you to all who participated in *Human Milk Feeding in Wisconsin: Mapping the Future* on November 16. Information from the meeting and follow-up survey are being used to shape the initiative.
- A follow-up meeting is scheduled for April 5, 2022, to share overall goals, measures, and change package elements for the initiative.

NAS/NOWS:

- The NAS/NOWS initiative will conclude in March of 2022.
- Within our NAS/NOWS initiative:
 - 88% of infants with NAS/NOWS are managed using a comprehensive care algorithm. (LifeQI Aggregate chart CenterLine)
 - 50% of infants with NAS/NOWS receive any of their own mother's milk within 24 hours prior to discharge.



Severe Maternal Hypertension - AIM Patient Safety Bundle

- The Severe Maternal Hypertension initiative started in October 2021.
- 44 Wisconsin hospitals are participating in this initiative.



- Collaborative goals:
 - By December 31, 2022, decrease severe maternal morbidity among pregnant/ postpartum women who experience severe hypertension among those hospitals participating in the collaborative.
 - By December 31, 2022, increase the percent of birthing patients with acuteonset severe hypertension that persists for 15 minutes or more, including those with preeclampsia, gestational or chronic, who are treated within one hour of first elevated blood pressure reading.
 - By December 31, 2022, decrease disparity gap among pregnant/postpartum women with acute-onset severe hypertension that persists for 15 minutes or more, including those with preeclampsia, gestational or chronic, who are treated within one hour of first elevated blood pressure reading.
